Beginners Guide to Grant Writing Workshop- February 21 and March 21 at the Hendricks County Fairgrounds 9:00~am-4:30~pm both days

Master Gardeners may find themselves looking at writing grant proposals for community projects and Association activities. This two-day workshop teaches grant writers of all skill levels how to prepare and submit a professional proposal. The workshop is geared toward those who work or volunteer for nonprofit organizations, educational institutions, community clubs, and local government units and departments. Participants will learn how to develop ideas for grant proposals, identify and work with funding sources, and understand the proposal development, submission and review process. Professional review of a draft proposal is also included. Registration is \$175 per person and includes a workbook, reference materials and lunch both days. ## **ANR Educator Report**

The new Purdue Master Gardener online volunteer management system is here! Active Master Gardeners, those who completed a minimum of 12 volunteer hours and six education hours and completed and turned in their signed volunteer agreement forms, have received an email with instructions on how to register in the new system. If you have not yet received this email, contact Janet Cunningham in our office and she can look into your active status and let you know what you need to do to get up to date. It is likely something as simple as turning in your volunteer agreement form to our office. The Purdue MG Manager online system provides a way for Purdue Master Gardener volunteers to report volunteer activity and educational training hours online, communicate details about volunteer projects, keep and maintain a personal profile, designate calendar of events as volunteer opportunities with an online volunteer recruitment for these activities, make use of a local MG volunteer directory, sign annual agreement forms electronically, and more! All Purdue MG's MUST register in the system. In order to register, you will need an email address and a county registration code. Your county registration code will be sent to you once we confirm you have met all requirements as outlined in the Master Gardener Policy Guide. This means there will be no more paper forms to turn in! If you turned in forms to the office already, Janet will be getting those back to you so that you can register and enter them in the new system.

This is a very exciting time and we have heard about this new system for a long time. I know John Orick has worked very hard to get this system up and running. With any new system, there is a learning curve. There will be a learning curve for all of us-volunteers, county coordinators and office staff. I ask you all to keep an open mind and practice patience as we all learn how to use this new system together.

If you have any questions, please don't hesitate to contact me or Janet Cunningham in the Extension office. We will do our very best to help everyone get registered into the new system and answer questions as best we can. If you don't have access to a computer, you can stop in the Extension Office Monday- Friday, 8 am – 4 pm and use a guest computer to get registered. It is a good idea to make an appointment with Janet. Please keep in mind the office opens promptly at 8 am and closes promptly at 4 pm, so be sure to allow ample time before 4 pm. Janet also takes an hour lunch each day, so it is highly recommended you make an appointment with Janet. Other office staff can get you set up on a computer; however they may not be able to answer specific questions about the new system.

To those of you who already registered and have tried entering hours, thank you for being a pioneer! I look forward to exploring this new system with you! I believe it will save us a lot of time in the long run, once we learn how to use and get used to it.
