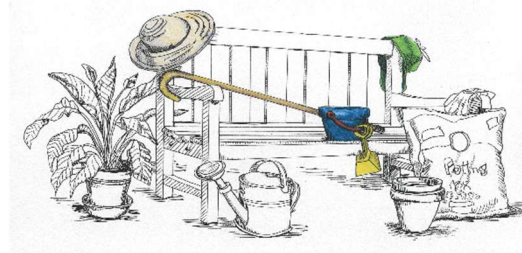

## President's Message

Greetings Master Gardeners. Hope this message finds you healthy, wealthy & wise. As I said last month, seems like forever since we have seen one another, and it has been nearly four months now. It has been refreshing to see or talk to a few of you on rare occasions, but I really do miss the regular interactions we usually have. We may have some opportunities before long, Lord willing and the "virus" creek don't rise.

In case you haven't heard, Purdue did not extend the curtailment of face-to-face interactions beyond July 1st, but instead are following the Governor's "Back on Track" plan with some restrictions. So many of our activities planned for the rest of the year MAY occur as scheduled. Although I am sure you realize that these activities will look very different than what we are used to as we institute due precautions. Consideration is being given to what we will need to do to move forward with these events, and we will make you aware of those as the time gets closer. The County Fair in July will be replaced this year with a 4H Exhibit Showcase, which will be essentially a 4H only event, so we will not have a booth or man the Demo Garden at the Fair. Watch your email and newsletters for more information on other events.

A quick update on the non-GFAA 2020. We refunded the fees to all the vendors who invested in booth space, some of them needed the funds more than us. We further offered refunds to our sponsors, all of which responded for us to keep the sponsorship donation or hold it till GFAA 2021. So a big thank you to Hendricks Power, Kramer Companies, Lawsons, and Dammann's for their generosity. We had already ordered and paid for the trees, John Dottenwhy picked them up and worked hard on finding homes for them. Several trees were donated to deserving groups such as the Avon Outdoor Learning Center, and many were given to the public at opportunities such as the 4H geranium pick up. Special thanks to Kati Sweet and the 4H Flower Committee for their assistance in this endeavor. Many of the seeds that were donated have been given away at food pantries, to the Correctional Facility, and other charity groups. We still have many seeds remaining but have decided to hold on to most of those. There seems to be higher than normal demand for seeds this year, and we fear the seed companies may not have the seeds

left over to donate for next year. So rather than have to purchase seeds for GFAA 2021, we decided to hold on to some of what we have.

Even though it may feel like it to some of us, HCMG is not at a full stop. We continue to adapt to our ever changing new normal and try to find what works. We will still award our annual scholarship if we have qualified applicants, but it will not be awarded at the plant sale as in the past. With the confusion created by the closure of schools, the deadline for the scholarship application has been extended to June 8<sup>th</sup> and the scholarship will be awarded in July. We are looking into staffing a booth at the July and August Farmers Markets if it is permitted. The Demo Garden has been considered as a community garden, so we ARE ALLOWED to work in the garden, even prior to July 1 with some restrictions of course, so watch the MG Manager for Demo Garden Volunteer opportunities. We will also be opening the Education Center by having volunteers research and respond to questions from their home, watch your email and MG Manager for further details and opportunities.

Kathy Moran and the Bylaw Review Committee have drafted a revision to our current Bylaws which is now being reviewed by the Executive Board. You may recall the purpose of the revision is to add the Assistant Treasurer and possibly another position to the Executive Board. We hope to be able to present the revision to the membership for review and adoption this fall.

I would also be remiss if I didn't mention, the 2020 Directories are finished, and have been finished since March. Debbie Off worked very hard on compiling and completing the Directories. Unfortunately, we have not had the opportunity to distribute them to you. We will have them available at the first opportunity.

If all goes well, we will be able to have Open Gardens starting in July. Since many of you have had a little extra time working in your home gardens this year, I am sure they are looking spectacular. Please consider hosting a Social Distance Open Garden. After spending all the extra time at our own homes, we all will be anxious to get out and see what others have been doing. Gardens need not be show quality, we all know

that any garden or landscape is always a "work in progress," and we all have a few weeds. You would not be expected to provide snacks, amenities or anything else, you won't even be required to place X's in your yard 6 ft. apart. Just let fellow MG's tour your gardens. The point is to share and show off your ideas, plantings and accomplishments, and maybe get a few ideas and suggestions from fellow MG's. Date and time are at your convenience, you decide. If interested, please let Sara Fenton know.

I know all of us have been looking for ways to help those less fortunate than us, and here is one small way.
