

The primary reason for the revision is to add two new positions to the Executive Board, an Assistant Treasurer and a Project Coordinator. The proposed revision also includes a few updates and cleans up provisions. I provided a "redline" version of the proposed revision and a summary of changes via email on August 11, and it's also available for review on the HCMG Website. The ratification of the proposed bylaw revision is on the October meeting agenda and will occur prior to the election. If the revision is approved, we can have the two new officers in place for 2021.

A big THANK YOU to the nominating committee, Vicki Coleman, Pat Dallas, and Chuck Dallas. At the September meeting, Vicki presented the slate for 2021 officers, who will be elected at our October meeting. Nominations will be accepted from the floor if anyone else is interested in serving on the board.
